**SPOTLIGHT ON ONE OF BRITAIN'S ALLEGED 'CRIME CORPORATIONS' -  
Aspect Maintenance Services Ltd.**

We are seriously concerned that many hundreds if not thousands of elderly, disabled and vulnerable people have been taken advantage of and defrauded of many thousands of pounds by Aspect Maintenance Services Ltd who allegedly operate a principal scam of 1). Luring in customers on a promise of 'very low prices and labour rates', 2). Have an Aspect 'chain-gang' of unqualified workers run several sites at once performing little or no work on site though claiming 'total hours' of 8am - 6pm x multiple workers, 3). Leave all tasks unfinished as per the Aspect 'snagging' get-out clause in the Aspect Terms and Conditions, 4). 'Pocket-Book' any professionally installed items that look newly installed as their own work as Aspect Workers are often 'picked off the street or from prison type environments' and struggle to achieve anything approaching a quality finish! 5). Serve their victims, the customers, a 'Massive and Disproportionate Final Bill of over £10,000' for achieving 'very little or no work!! 6). Attempt to treat this 'Huge Final Bill' seriously & hire 'highly aggressive solicitors to obtain settlement'!

**CASE HISTORY - HUGE SUM OF MONEY ALREADY PAID BY MRS  
WHITEHEAD - ALMOST DOUBLE VALUE OF WORKS!**

Aspect Maintenance Services Ltd have already been overpaid as matters stand by a sum in the region of £3,500 with the unfinished Aspect Works amounting to less than £4,500, Mrs Whitehead has paid the sum of £7,881.40p for around 30 hours worth of work including minimal materials, merely two cheap toilets worth around £50 each, a bath panel costing approximately £20, cheap £15 towel rail, possibly cheap French Doors worth around £200, though these look like the original French doors refurbished at very low cost, a few pots of paint, though the vast majority of the 'very high quality materials were all provided for by Mrs Whitehead. Aspect Final Bill Claim amounts to an additional £14,276.41p as claimed for in the English Courts!! Nothing of any value such as i. a conservatory, ii. 13 new windows or iii. rear extension, etc, were ever bought & fitted by Aspect!

Worse still is the 'Living Hell' that the Whitehead's have endured from repetitive Aspect Telephone Calls, Emails, Messages, Tweets and 'Legal Action' Documentation over the last 2 year period when Aspect have been 'paid entirely generously already for works part-achieved' at £7,881.40p and Mrs Whitehead should be part-refunded an amount in the region of £3,500 as few tasks were attempted by Aspect and none ever finished, often by up to 80% unfinished.

**DISTRICT JUDGE COOPER & OTHERS TO BE SUED FOR £20M !**

Architects of this 'Whitehead Disaster' cannot purely be pin-pointed at Aspect, many others must take the blame for 'Serious Hardship Upon Whitehead Family' such as District Judge Cooper who may 'let the miscarriage of justice pass' which will result in 'Direct Liability' being apportioned to Principally District Judge Cooper and to a lesser extent, 'others' within the Judiciary and Court Network. Mrs Whitehead could ultimately be forced into Bankruptcy by the decisions of 'folly and negligence' from District Judge Cooper with Mrs Whitehead's son, KRW, who is the sole beneficiary of her Will and Legacy which will likely amount to more than £20Million (Gbp) over the next 20-25years, Mrs Whitehead is a youthful 74 and KRW grandmother is still alive at 95. Mr Cooper is to be served a Draft Summons for the £20M Inheritance he is deliberately depriving KRW of in the coming days unless District Judge Cooper 'Strikes-Out' the Vexatious, Scurrilous, Ill Conceived, Wrong Claim against Mrs Whitehead by Aspect Maintenance Services Ltd.

Hateful Cooper has 'let matters go too far' in this alleged 'claim of lies'!!

### **KRW QUALIFIES FOR 'REPARATION' - COMPLETE LEGAL AID**

Very soon it shall be District Judge Cooper's turn to 'sweat in a cooker' for 2 years or more as a highly legitimate Compensation Claim of £20Million is going to be raised against Cooper and to a lesser extent, others, for supporting their 'friends' at Aspect Maintenance Services Ltd, who have 'no evidence' to warrant raising a claim against Mrs Whitehead, a lady who always pays her bills generously and who has had no previous experience of accusations against her for not paying tradesmen appropriately. The loss of Mrs Whitehead's 'Million Pound Property Company', which may be the case should District Judge Cooper fail to act responsibly and neglect his duties shall ensure that KRW's very substantial inheritance of likely more than £20Million shall be deprived of him by the in part 'gross-negligence' and in part probable, 'conspiracy to deprive the individual of very substantial funds' along with other mitigating factors.

The above outcome would be an enormous injustice ranking among the most serious in UK Legal History in modern times and the court action at that point has only just begun as several Law Firms have expressed a serious interest in taking Legal Action in this matter on behalf of KRW against The Crown and individuals.

Full Legal Aid, 'Reparation' will be granted in this case, allowing solicitors and barristers to 'quickly round upon Cooper, and those involved in this crime. It is very likely that District Judge Cooper shall be suspended pending an enquiry.

### **ANOTHER UK FIT-UP ON WHITEHEAD FAMILY!!**

Many UK Crown, Judiciary and Police 'Fit-Up's', 'Framings' have been thrust upon the Whitehead family over the years, including 'a bizarre accusation that KRW had set fire to the Tate Gallery in London' and at least 2 other Galleries in Glasgow, all of which are untrue, KRW's singular offence is a 'very minor public nuisance' matter relating to KRW being victim to an attempted sexual assault by touching in the Tate Gallery by 'one of the internal homosexuals', using the otherwise considerable reputation of the Tate Gallery, it's History, Façade and Grand appearance as an escape or disguise for attempting to 'touch-up' a recognisable young emerging wealthy talent. After a while, the Irish Fishermen peacefully left the premises.

KRW was requested to freely attend the local Police Station where he was subsequently charged with a number of offences.

This case lingered around for a while though all charges were dropped on the evidence and proof as presented as KRW had not committed any offence and indeed was praised as was his staff for 'managing a potentially volatile situation without any harm being caused to any person', given KRW's training to his staff to ensure the tills are always closed within time, no drinks served after hours and to ensure the doors are well managed to allow persons to leave and not to enter.

There are obviously a number of alleged 'criminal systems' at work relating to the manner in which those at Aspect decide to 'Process The Individual' Customer for alleged Exploitation and Additional Large Sums of Money, without question, potential and actual customers of Aspect are 'repeatedly vetted' by Aspect Staff as to the customer's suitability for a substantial alleged fraud against them, such as; 1). Do you think that customer has a lawyer handy, 2). Do you think they can afford a lawyer just now, 3). How much extra cash do you think they are good for, 4). Did you get any info on the number of assets, like houses they have, 5). Do they have a holiday home, a Boat or a Caravan, 6). Do they have any shares or other investments and do you think they would be willing to sell an asset such as a holiday home to pay for our ahem.. 'work'.. hah, ha, ha.. If you know what I mean... 


## **ALLEGED ASPECT COMPANY DIRECTIVE**

## ALLEGED MAJOR SUSPECTS AT ASPECT MAINTENANCE SERVICES LTD

### Suspect Number 1: Co-Founder and Managing Director - Will Davies.



Davies has a long and chequered history in the finance sector, having lived in Australia and worked as an Investment Banker he stumbled into Property Maintenance while out of work and knew Nick Bisley, his partner from previous meetings and formed Aspect from a shed in a corner of Battersea Business Park in 2004. Davies is undoubtedly much of the alleged 'brains behind the operation' and it has been Davies that has 'orchestrated the financial circus and subterfuge' around Aspect to enable 'Rapid Progress' in the Property Maintenance Industry. It is noted that Davies and Aspect Pay 'virtually no taxation to the IRS' (Inland Revenue Service). Is Davies a Catholic as KRW has suffered 'repeated vicious attacks from Catholics over the years'?

Will Davies has the fair haired, blue eyed appearance of an Aryan who may consider himself to be superior to his customers. Davies also has a certain unkempt, untidy appearance about him, suggesting a 'cocky character', with his alleged 'smug and sneering smiles', these traits are of great concern. It was Nick Bisley that had the first Aspect Van back in 2004 when this problematic company first began from a shed in a corner of Battersea Business Park. It does seem that Bisley does not have the training experience and ability to enable a good and well skilled work force. The Aspect 'Handyman Diploma Certificate' is deemed by the Trades to be 'Worthless' and many reputable companies will not employ those previously employed by Aspect!

Both Davies & Bisley sadly have

the alleged hard rough appearance of 'a couple of nutters', alleged psychopaths!

### Suspect Number 3: Finance Manager - Antonia Achenbach

Achenbach is an unusual character, seems to have an Australian Accent with a German surname and Italian / German Christian name. Achenbach only cares about money coming in to Aspect bank rolls, nothing else and it is the many shortcomings of Aspect as an entity that forces the Finance Department to allegedly send 'fake' Final Bills to vulnerable customers to either settle or be sued!

Will Davies, Managing Director of Aspect Maintenance Services Ltd is a former Investment Banker and he will know all of the Taxation and Profitability Loopholes possible and Offshore Loan Facilities and 'get-out' programmes and formats to maximise his income & profits from Aspect while paying no Tax or very little Tax!

Possible VAT Scams may proliferate the Aspect Account Books where Aspect, already paying little or no Tax could, with the skills of an accomplished Investment Banker that knows the routines, loopholes and system, actually be Paid tens of thousands, indeed, Millions of Pounds of Tax Payers Money by allegedly falsifying Accounts in order to create a vast VAT Rebate scenario, imagine that, the Aspect weary public actually paying Aspect from their own Tax to perform shoddy jobs!

Such a VAT Rebate would be on top of the already 3times to 15times and in the case of the Whitehead Job Sheet, sometimes, 50times or more the cost of the Job as quoted and as per 'Industry Standards', which is why Aspect have risen from a grisly birth under a rock to become a £20Million per annum company in 15years!!

## 'MINIMAL' OR NO TAX ON PROFIT EXAMPLES OF ASPECT

As can be viewed on the opposite page, the Aspect Financial Figures from 2016 to 2017 amount to in 2016, Aspect showed a Turnover of some £12.5Million and paying Corporate Tax of 8% this should have amounted to a sum of £1Million at the highest Tax point of the Aspect Accounts. Aspect have indicated a Cost of Sales at £8,107,442, though in order to do this Aspect must be able to prove this figure by way of 'complete and entire vouchers' with any unproven amounts being Taxable. KRW &7 Co do not believe that Aspect have the necessary Vouchers and Proof to have cost of sales accepted at £8,107,442. Furthermore are the cost of Administrative Expenses at £4,164,790. This figure seems disproportionately 'very high' and can easily be falsified by 'fake franchise agreements', many other financial techniques and other scams. These two figures combined allow an 'Operating Profit' of merely £233,011 which is 'Barely a London MD's Salary' and certainly does not make any sense at all and appears to be recorded as 'Artificially Low' In Order To Avert Taxation Payments. Worse still, the following year's Accounts show a similar trend as if a certain Investment Banker has 'cracked the system' and is so lazy as to change the successful routine at the Tax Office.

Given these figures on the facing page, it does appear that there is a large scale alleged Tax Fraud and Embezzlement Strategy in play here with Aspect.

In 2017, Aspect paid 6% Tax on a probable alleged 'fake' Operating Profit of only £988,674 from an annual Turnover / Income of a huge £15.05Million which quite simply does not make sense. Crooks always knit into the figures 'at a glance' real figures for reference and it is suspected that the Gross Profit of £6,266,631 is the slice of Will Davies with Operating Profit of £988,674 Bizley's yearly portion.

Although the UK Government entirely support British Business, such 'worthless' companies as Aspect are slipping through the net, a blight and permanent nuisance to UK Customers, the menace and terror to the elderly and vulnerable who own their own home on a low income and cannot afford a solicitor to pay the alleged deranged Aspect 'Fake Final Bill', so unscrupulous Aspect Lawyers take your house instead! Aspect are a National Insult and UK Embarrassment with various likely alleged financial scams having Public Taxes in conjunction with 'Fake Bills' pay several times over for a service that often does not exist or is so worthless the housewife would do better attempting to repair her own boiler!!

Aspect are alleged unquestionably, 'a worthless company to UK, utterly useless'!!

## **KRW POLICE & SECURITY HISTORY**

On speaking with Aspect Workers, KRW, who has a measure of Police and Security Training from a very young age, his father, Iain was an Officer in the Royal Navy and KRW lived on a Naval Base surrounded by several thousand Police Officers and Security Personnel. KRW's first scientific acquisitions were finger print taking and forensic detective kits and board games such as Cluedo & KRW with greater experience has assisted the Police on many occasions to apprehend suspects and serious criminals throughout his years.

### **MANY ALLEGED ASPECT BOILER-ROOM SCAMS!!**

Just pop the old lady's house and her summer cottage on to the Aspect books by way of a crazed court case as the little old lady failed to pay her £18,500 bill to Aspect for oiling the garden gates and replacing some foam, somewhere. Next step in the 'crazed Aspect money drug ride' is to enlist the alleged 'evil skills' of Markel Law LLP, who deal with 'abusive little old ladies that refuse and cannot afford to pay for £18,500 for little or no disastrous and impossible shoddy works.

However, Aspect have 'an element of evidence', they did attend site, though the reasons why are very sketchy, Aspect like to keep it that way so they can 'move their story around' and flip-up unexpected costs and extra excuses and stories while their victims invariably start to flounder and lack the respect of the courts in England, who are 'extremely snobbish over persons defending themselves' and therefore the poor little old lady starts to feel the earth moving from under her and it certainly was no Aspect digger as no person in Aspect has likely ever seen one!!

It appears that Aspect Workers are more interested in alleged 'scams' than any real work in the property maintenance sector, scams which include:

- 1). Using anonymous token mobiles to write highly supportive trust pilot reviews.
- 2). Parking vans on empty customer drives to use for other jobs.
- 3). Constantly dodging Parking Fines instead of paying them!
- 4). Using customer skips, driveway, gardens for dumping rubbish from other jobs!!
- 5). Running 4 sites at once, claiming for constant site attendance when absent.
- 6). Having 'phantom workers' and claiming for hundreds of 'ghost hours'
- 7). Dragging out tasks & 'Super-Milking' Jobs by using sites for a break or sleep.
- 8). Falsely Quadrupling+++ site labour when only 1 Aspect Worker is present!!
- 9). Faking 'snagging faults', false delays and faking 'unforeseen problems'!!
- 10). Picking fault with both customer and property, playing the 'shame-game'!

- 11). Billing for parts and materials that were never used on a job & do not exist!!
- 12). Disproportionate huge Hours versus no Large Items Installed is an indicator.
- 13). Reusing windows & doors, items, billing for these as new, removing the old!!

### **KRW WORRIES FOR MANY VULNERABLE OLD PEOPLE**

So many elderly victims of crime do not have anyone, let alone a son like KRW!! Many unfortunate elderly people exist who have a very low income and a bought and paid for private or council house and therefore cannot afford a Solicitor to defend themselves from the alleged 'Spiders Web of Aspect Lies'.

Problem being in these circumstances is that Judges are almost always in support of well presented, apparently professional English Companies who appear to operate a successful and legitimate business over a number of years, even though with Aspect Maintenance Services Ltd, any Judge could be easily fooled by one of their alleged complex boiler-room plots against a vulnerable victim. As ridiculous as it certainly seems after some investigation of Aspect, this alleged company of crooks can seem very legitimate on paper, especially when their side of any fable s presented by a hired firm of reasonable solicitors just to bamboozle and confuse people further. Aspect also record some telephone conversations which can cause further trouble for those people who do not.

Therefore, even though customers are allegedly being repeatedly lied to and defrauded by alleged Aspect Workers and Senior Management, Aspect could manage to have more contrived and falsified evidence than their victims which could tip the balance of the scales of justice in favour of the crooks at Aspect.

In a nutshell, Aspect Workers have allegedly concocted so many lies and frauds that 'they know what they are doing', while innocent customers are very much submersed in a 'rookie experience', which even for the highly adept, cautious and well trained, such as KRW, it was very difficult keeping track of successive alleged 'lie upon lie' from Aspect and what those alleged lies would mean going forward.

### **KRW TOOK 'EVERY PRECAUTION WITH ASPECT'!!**

KRW has a Security / Policing background from a very young age and has in the early days, before around 2005 when digital Dictaphones became available, fallen foul to 'English Lies' and Liars in other parts of the United Kingdom. As the property was only built on 23.07.1999, to modern day standards, the entire home was in 'very good condition' when Aspect began their 'very small scope of works' in May 2017 when the property was only 17 years old. 



### MRS WHITEHEAD REQUIRED WORKS IN MORE DETAIL

Worksheet given to Aspect was 'very basic and straightforward', though from day 1, all Aspect Management and Workers involved with the 'basic work brief' found it very difficult to follow basic requests and instructions. In essence, the mandate was to 'return the small 3bedroom property back to a 'good standard' once more', by way of a 'basic refurbishment' of painting, cleaning, repairs and upgrades amounting to a >£5,000 budget or thereby. All Aspect Workers that KRW spoke to were 'very welcoming and compliant over this small budget'!! All quotes from Aspect were 'very low' which is why KRW gave Aspect the business. KRW followed all the same procedures as with all other tradesmen & such companies!

Works initially requested were as follows.;

- 1). Remove all rubbish and small items left by former tenants.
- 2). Paint internal walls and ceilings of very small house.
- 3). Plaster downstairs ceilings to remove Artex swirl effect.
- 4). Replace two toilets and repair small leak.
- 5). Remove insulation from loft and renew.
- 6). Install carpet upstairs, vinyl in kitchen and laminate flooring in lounge.
- 7). Basic landscape of gardens and clear small amounts of rubbish.
- 8). Replace standard light fittings with Argos basic type designer light fittings.
- 9). A few other 'very minor, remedial, basic tasks'.

With a separate budget of around £2,000 to £3,000 carry out the following:

- 1). Fit a new kitchen.
- 2). Paint all windows inside and out and window sills.
- 3). Install substantial rear garden partitioning fence between garage and house\*.
- 4). Replace front left boundary picket fence with brand new picket fence.
- 5). Replace Garage Door.

All materials and items required for the tasks were supplied by Mrs Whitehead.

All materials supplied were 'of very high quality' and 'fast to work with'.

First 9 minor projects were almost all attempted, indeed, the plastering task on the downstairs ceilings was reasonable in areas though had to be further patched by an alternative company. Most tasks were incomplete by up to 80%.

Additional 5 tasks were not even attempted by Aspect as Aspect had no workers skilled enough to attempt 'slightly more complex tasks', a few fat-pack kitchen units were attempted though were of such poor quality, even Aspect stopped!!

### TIMELINE OF ALL ASPECT WORKS (ALL LEFT UNFINISHED).

All works or part-works is more appropriate were attempted by Aspect mostly sporadically between 09.05.2017 and 25.05.2017 carried out by 1 Aspect Worker.

06.05.2017 to 08.05.2017 was a London Holiday, Saturday, Sunday, Monday.

09.05.2017: Clearing waste, lifting flooring and breaking up old kitchen. 3hours.

10.05.2017: Removal of any small items of former tenant rubbish or household items in preparation for refurbishment. 2hours.

11.05.2017: Preparation of walls and ceilings for painting works. 1.5hours.

12.05.2017: Fitting 2 toilets, basic plumbing tasks by an Aspect Worker. 3.5hours.

13.05.2017 to 14.05.2017, Saturday and Sunday Weekend. No Working.

15.05 and 16.05.2017: No attendance by any Aspect Workers.

17.05.2017: Upstairs Painting by an Aspect Worker. 4hours.

18.05.2017: Upstairs Carpet Laying by Aspect Workers. 3hours in total.

19.05.2017: Downstairs plastering by 1 Aspect Worker. 3hours in total.

20.05.2017 to 21.05.2017, Saturday and Sunday Weekend. No Working.

22.05.2017: Installation of French Doors. 1hour. Loft insulation renewed. 1hour.

23.05.2017: Painting Downstairs and Fitting of Light Fixings. 4hours in total.

24.05.2017: Remaining Flooring laid downstairs. 4hours in total.

25.05.2017: Minor finishing tasks. 1hour. - **Total Hours - 30Hours Only!!**

26.05.2017 to 29.05.2017: Public Holiday on Friday, Saturday, Sunday, Monday.

30.05.2017: No further works carried out by Aspect.

31.05.2017: No further works carried out by Aspect. Locks changed KLS by PAW.

KLS are Kent Lock Smiths, owned by B. Fitzgerald, locksmith of Mrs Whitehead.

Above Timeline was deciphered from Aspect telephone calls, emails & other data.

### WORKS ACHIEVED BY ASPECT WORKERS

In more detail, Aspect Workers achieved 'virtually no tasks' unaided by proper tradesmen not associated with Aspect Maintenance Services Ltd !!

Aspect Maintenance Services Ltd are 'by a fair measure, the worst maintenance company that KRW has ever had to deal with in over 30 years'!!

All works were left unfinished by mostly 80% or so reducing to 20% for a few.

**BIZARRE HUGE PRICE CHARGED BY ASPECT OF £22,157.81p ??? 10x ACTUAL!!**

Above prices & allocations are generous and amount to 30hours or £2,340 only!!

Aspect's hourly rate is £78 inc. VAT, thus where does £22,157.81p come from?

### ASPECT COULD STILL BE 'GREATLY IN PROFIT' AT 30HOURS

Aspect Maintenance Services Ltd 'purported' reduced hourly rate amounts to £78 Including VAT at 20% and multiplied by 30 hours work time, if that, amounts to £2,340 as stated previously. Aspect could very much 'still be greatly in serious profit' at this price as those 30 hours could have been achieved by hiring one permanent Handyman Aspect Worker who is paid say, a generous wage of £15per hour for 30 hours work amounting to £450 for the worker and around £350 for materials as most materials were provided for by Mrs Pamela Whitehead.

That £350 materials cost would over 2 basic cheap toilets at around £50 each and £200 for the new French Doors though it is believed those were likely replaced with the old French Doors that had been 'lightly refurbished' as the lock mechanism appears corroded and one side of the glass door is slightly faded along with the external UPVC frame as opposed to the internal frame.

A further £50 for small items and materials, most of which is 'borrowed or found from other sites' and therefore not charged for. This bill amounts to £350 to be added to the £450 for labour or £800 in total to be subtracted from the £2,340 that should have been the maximum paid for the entire minor project leaving a very substantial amount of £1,540 company profit which is more that 3 times the amount that was paid as 'a very healthy wage' to the man that actually performed the tasks on the property. In the event, the minor project was 'SUPER-MILKED'!


